

Minutes of the 2nd Meeting of Core Team of Vishwa Sindhi Hindu Federation of Associations held at 11.00 am on 7th January 2024 on Zoom.

- Shri Bhagatram Chabda ji had asked for some time to rejoin us. Therefore, the meeting was called to order by Shri Rajaram Bhagwani ji at 11.00 am sharp and he welcomed everyone and requested to participate positively and actively to follow the agenda of the meeting.
 - Minutes of the last meeting held at Pune on 14th December 2023 were read by Dr. Raju V. Manwani ji. And some queries were asked and clarified by the members present at the meeting.
 - A few changes in the minutes requested by Dr. Ravi Prakash Tekchandani ji.

- **And the following points have been resolved.**
 - **All the core team members except advisors should fill up their forms through their respective associations, panchayats, or trusts as soon as possible represent the federation.**
 - **The Federation name was finally decided as VISHWA SINDHI HINDU FEDERATION OF ASSOCIATIONS.**
 - **Governing council members of 7, 9, or 11 are to be registered before the next Zoom meeting. They requested the Mumbai team to take action fast and register. The following names were suggested initially for the Governing council members of the federation.**

- Also decided that every Governing Council member to deposit Rs. 51000/- for small expenses and other expenses to be deposited with Dr. Pitambhar Peter Dhalwani and Shri Kishore Kumar Parwani ji.
- It is decided to suggest names for temporary convenors till 21st January 2025, as decided in the first core team meeting. In one state, there will be one convenor and two Co-convenors. If the state is big enough, there will be 3 co-convenors. The decision can be made at the next Zoom meeting on January 18, 2024, at 9:00 PM.
- It is also decided that as of now Now 2 Sindhi Federations have already been declared, hence we have to try to keep only 1 Federation for the benefit of the Sindhi community. So, Shri Manohar Mamtani ji and Dr.Pitambhar Peter Dhalwani ji will be coordinating with the other federation and will decide in 2-3 days.
- All country representatives' names were also asked to suggest in the groups to take a final decision on 18th January 2024 meeting.
- As well, all the saints can also be suggested as Margdarshak or advisors with Shri Indresh Kumar ji.
- Dr. Ravi Tekchandani ji suggested that only registered associations, panchayats or trusts should be the member of the Federation. Additional unregistered associations, panchayats, or trusts may also complete and submit the form; however, they must first obtain the necessary instructions from the federation in order to register and become members of the federation.

- **Dr. Ravi Tekchandani ji also suggested that Sindhi University can be anywhere not only in Kalina, as Shri Indresh Kumar ji already declared one Sindhi University in Leh Ladhak. Therefore, Kalina name should be removed from the previous meeting minutes.**
- **It is decided that the right word for Youth involvement in Politics will be “To Secure Political Justice to Sindhi Hindu Youth” or “Empowerment of Sindhi Youths to secure Political Justice.”**
- **He also suggested that Indian Constitution should be strictly followed and accordingly act as nobody can point out any mistake.**
- **Shri Rajaram Bhagwani ji also suggested that Vishwa Sindhi Hindu Federation of Associations would assist and help the unregistered associations, panchayats and trusts. This law may not be applied for Advisors; they can be join us as from any country.**
- **The Federation should appoint a legal advisor to provide guidance on all Federation operations.**
- **Shri Manohar Mamatani ji has suggested that the right word for legal advisor is Juridical Person (Legal Person).**
- **Juridical person or legal person was referred for the members of the Federation irrespective of their status as society or club or Associatio or firm or company etc registered under any central or state laws.**
- **Shri Pawan Sindhi ji recommended that the formalities should be finished as quickly as possible and that should begin communicating with the government right away because those who wait the longest will be given priority by the authorities for Sindhu Bhavan etc.**

- **The right word will be Governing council and not trustee in society act, this will be discussed with the legal advisor.**
- **Shri Kishore Parwani ji suggested that the Convenor and Co-convenor should be in the same state from different cities so that all representation can be done properly**
- **Concluding remark by Dr. Raju Manwani and he conveyed each and everyone that it was a great positive and encouraging meeting today. He requested for the suggestions and guidance in the future also. Every one missed Shri Bhagwandas Chabda ji in his absence.**
