- Raju Manwani conveyed in the meeting the advice given by the Legal Officer about the possible problems at the Registrar's office. He suggested that the registered office could be at any place other than Mumbai and this federation could be registered anywhere out of Mumbai, but everyone unanimously suggested that the office has to be registered in Mumbai only.

- The word trust should not be used anywhere. Dr. Ravi Prakash Tekchandani ji has suggested that the word Governing Council or Federation should be used everywhere.

- This Federation has to register under the Society Act

- Also decided that Governing Council members will be allowed to continue till 21<sup>st</sup> January 2025. After that selection will be through election or selection according to the rules.

- Work will be divided accordingly after the registration of the federation under Society Act. And will be decided that who will be taking care of Administration, finance and other committees etc.

• The core team members present in the meeting had given valuable suggestions and guidance in positive way. And everybody was happy regarding today's meeting.
