




CONSTITUTION OF THE –

“VISHWA SINDHI HINDU FEDERATION OF ASSOCIATIONS”

.....RULES AND REGULATIONS

1. **NAME:** The Federation shall be called the **“VISHWA SINDHI HINDU FEDERATION OF ASSOCIATIONS.”** (Hereinafter referred to as the **“VSHFA”**)
2. **AIMS & OBJECTIVES:** The aims and objectives of this **“VSHFA”** would be as under:-
 - e. To promote and safeguard the interests of Sindhi Hindus all over the world;
 - f. To deal with all matters pertaining to the welfare, conditions and prospects etc. of Sindhi Hindus, and
 - g. To inculcate a sense of fraternity and unity among the Sindhi Hindu Associations,
 - h. To represent member Sindhi Hindu associations in national and international forums , private or government.
3. **MEMBERSHIP:** The Association/ Panchayat/ Institution/ Group/ Organization/ Trust/ Company etc of Sindhi Hindus registered with the respective government, at national and international level shall be eligible for affiliation to the “VSHFA”. The affiliated National and International Associations of Sindhi Hindus would be required to contribute a sum of Rs. 1000/-and Rs.1000/- respectively towards the Joining Fees for defraying the expenses of the **“VSHFA”**
4. **SUBSCRIPTION:** The affiliated National and International Associations of Sindhi Hindus would be required to contribute a sum of Rs. 1000/- and Rs.1000/- respectively per annum towards annual subscription fees for defraying the expenses of the **“VSHFA”**
5. **MANAGEMENT:**
 - (i) The General body of the **“VSHFA”** will be constituted by the 02 (Two) each nominated/ elected members of the registered Sindhi Hindu Association/ Panchayat/ Institution / Group Organization/ Trust/ Company etc constituted for the welfare of Sindhi Hindus in India or anywhere in the world duly registered with the respective Government as per the legal provisions of the respective Governments. The copy of the Certificate of Registration should be deposited to the Secretary General of the federation within 15 days the completion of the validity of previous date. The member of the association/ panchayat/ institution/ group Organization/ Trust/ Company etc will not have the voting right on the day of the voting if the registration of his association panchayat institution group Organization/ Trust/ Company etc is not valid as on date as per the document submitted by the said association panchayat institution group Organization/ Trust/ Company etc. This responsibility will lie on such member of the respective association panchayat institution group Organization/ Trust/ Company etc to submit a copy of the updated certificate of registration of his association panchayat institution group Organization/ Trust/ Company etc to the federation at least 15 days before from the date of voting that his Association panchayat institution group Organization/ Trust/ Company etc has validity on the date of voting.
 - (ii) - The total strength of the General body will be according to the number of the association/ panchayat/ institution/ group etc joining the federation.
 - (iii) + 10% of the General body, but not more or less then 30, as detailed in clause 6 (i) below will be elected to the posts of Governing Council,

- (iii) The governing council, by majority, may co-opt eminent persons / person of choice to work as **advisor** of any number, of Sindhi Hindus who can help the “**VSHFA**” in getting the goal of the federation achieved. Such members will not have any voting rights.
- (iv) Further in order to have continuity of the office bearers and associating some persons of choice to work as Coordinator / Co-coordinator, the governing council can nominate individuals belonging to Sindhi community as nominated members of the association without voting rights.
- (v) Further the present body is ad-hoc and will hold office upto 25 th Jan 25 or a proper date nearby as per **Law**. Meanwhile, General body will be set up by getting registered Sindhi institutions etc as members of the “**VSHFA**” and the condition of bar on re election will be applicable to the elected body only. The office holder of this body will not be barred for re-election on the ground of having held any post in as hoc body.

6. GOVERNING CONCIL:

- (i) The “**VSHFA**” shall have a Governing Council consisting of the following:
 - a) 01 President
 - b) 10 Vice Presidents, out of which three will be from outstations.
 - c) 01 Secretary General
 - d) 05 Secretaries,
 - e) 01 Treasurer,
 - f) 10 Joint Secretaries,
 - g) 02 Joint Treasurers
- (ii) In addition the immediate past President and **Secretary General** shall also be the member of Governing Council without any voting rights.
- (iii) Tenure of Governing Council will be 3 (Three) years.
- (iv) **MODE OF ELECTION:** The office bearers of the Governing Council shall be elected in a General Body meeting called for this purpose. The Electoral College for the election shall be all the members of the General Body having voting rights.
- (v) **VACANCY:** In case of resignations, retirements etc the Governing Council will have powers to co-opt office bearers from amongst the General Body representatives.
- (vi) No one will hold the post of Governing Council for more than 2 tenure either in continuity or broken spell. Person holding the post of President will not be eligible for any other post in Governing Council subsequently. **The person holding the post of Secretary General will be eligible to hold post of Secretary General or President only.** Others will be eligible for holding any of the post except the same post on completion of two tenures either in continuity or in broken spell. For example joint secretary will not be eligible after two tenures either in continuity or in broken spell for the post of joint secretary but he will eligible for any other post in the federation..
- (vii) **QUORUM:** More than 50% of the elected members of General Council (Minimum 16 members) shall form quorum. All questions under consideration shall be determined by a majority of votes of the members present and voting other than Presiding member.
- (viii) **CASTING VOTE:** The Presiding member shall not vote in the first instance, but shall have and exercise a casting vote in the case of an equality of votes

- (ix) **MEETINGS:** The Governing Council shall meet at least once in six months.

7. DUTIES OF OFFICE BEARERS AND OTHERS:

i) President

The President shall be the head of the "VSHFA" and he shall preside over all meetings of the Governing Council or Annual General or Special General Meeting and meetings of the Governing Council. He shall guide "VSHFA" in all its activities. He shall exercise superintendence over Office Bearers and members of the Governing Council and other Committees in the discharge of their duties. He shall have all powers of supervision over their duties. He shall have overall power of supervision over the working of the "VSHFA" and its efficient administration. In particular, the President shall have the following Powers/responsibilities:-

- a. To implement the objectives of the Federation.
- b. To deal with all disciplinary matters arising in "VSHFA" or in the State Associations as per Rules on the subject. This would be subject to ratification in the next Governing Council Meeting of the "VSHFA".
- c. The President is authorized to sanction the expenditure upto Rs.10,000/- for any one item. Expenditure in excess of this amount shall be sanctioned by the Governing Council.
- d. In case of a tie except in the General election, the President will have a right of casting vote.
- e. The President shall ensure that the financial position of "VSHFA" is strong and that no unauthorized expenditure is incurred.
- f. The President may perform any other task/functions as directed by the Governing Council or the General Meeting.
- g. President may direct to General Secretary to Conduct / call any kind of meeting.


ii) Vice-President

In the absence of the President, the **Senior most** Vice President by order of precedence shall preside over the meetings. In the event of prolonged absence of the President, the **senior most** Vice President will take over the duties and responsibilities of the President during the period of absence. In the absence of Senior Vice President

The Vice Presidents may perform any other tasks/functions as directed by the President, the Governing Council or the General Assembly.

iii) Secretary General:

- a. Subject to the general control of the Governing Council, the Secretary General shall be in charge of the day to day administration of the "VSHFA" and shall transact all official business in accordance with the decisions of the Governing Council.
- b. He shall be responsible for calling meetings of the Governing Council as per rules and implement their decisions.
- c. He shall carry out all correspondence in the name of the "VSHFA" save as otherwise directed by the President.



- d. He shall keep and maintain the Minutes of all meetings of the "VSHFA", the Register of members and all such records as may be necessary for the smooth and efficient working of the "VSHFA".
- e. He shall also be responsible for the maintenance of the properties (moveable and immovable) of the "VSHFA".
- f. He shall prepare and submit the Annual Report to the General Assembly at an Annual General Meeting of the "VSHFA".
- g. The Secretary General shall ensure that the Accounts of the "VSHFA" have been regularly audited. The financial power of the Secretary General are restricted to sanctioning of Rs.10,000/- Any expenditure exceeding the said amount shall require the previous sanction of the President or the Governing Council.

iv) Joint Secretaries :

The Joint Secretaries subject to the control of the Secretary General and the Governing Council shall perform such duties as may be assigned to them from time to time. They shall help the Secretary General in each and every matter of the "VSHFA".

v) Treasurer :-

- a) The Treasurer shall do all financial transactions of the "VSHFA", pay bills approved by the Governing Council or certified by the President or Secretary General unless the amount of a bill exceeds the budgeted amount in which case the excess amount must have the sanction of the Governing Council before it is paid.
- b) He shall maintain the books of accounts submit Half-Yearly Statement of Accounts and get the Accounts duly audited in time.
- c) He shall also maintain an inventory of the Association's property and submit the same along with the audited Accounts.
- d) The Treasurer shall not keep with him any amount exceeding Rs.10,000/- but shall deposit the same, within one week of its receipts, in a Bank approved by the Governing Council. All receipts shall be signed by him.

vi) Joint Treasurers:-


Joint treasurers will assist treasurer in doing his assigned duties and will act as treasurer in case of his absence.

vii) Administrative work force

The Governing Council may appoint one Administrative officer and more sub administrative officers and supporting staff for the "VSHFA" to look after the day- to-day administration of "VSHFA" Secretariat under the guidance and supervision of the Secretary General and President only. The financial powers of the Administrative officer will be restricted to the sanction of Rs.10,000/- for any one item.

7. ACCOUNTS

- (i) The treasurer shall prepare the Annual Accounts of the receipts and expenditure of the "VSHFA" as on 31st March of every year.
- (ii) The accounts will be audited by an Auditor nominated by the Governing Council
- (iii) The accounts for each financial year shall be submitted to the General Body meeting of the Federation.



8. MEETINGS


- (i) The Annual General Body Meeting of the "VSHFA" shall be held soon after the close of the financial year.
- (ii) At least 30 days notice shall be given for the Annual General Body Meeting.
- (iii) **The Quorum for the General Body meetings shall be minimum 40% of the members of the General Body**
- (iv) The Secretary General shall present the Annual Report of the activities of the "VSHFA" at the Annual General Body Meeting.
- (v) Quorum for calling the general body meeting at the written request shall be **minimum** 10% of the members of the General Body having voting rights as on the date of meeting and as on the date of demanding the meeting.
- (vi) An extraordinary General Body Meeting can be convened as and when the Governing Council considers it necessary to call one. It shall also be convened at the written request of not less than **5% of the** members of the General Body. At least 14 days' notice shall be given to all members for an Extraordinary General Body Meeting.
- (vii) Decisions shall be by majority vote which shall ordinarily be taken by a show of hands.

9. POWERS TO AMEND CONSTITUTION:

An amendment in the Constitution of "VSHFA" may be made by a majority of the total membership of the General Body and majority of not less than two-third of the members present and voting on the date of consideration of amendment.

10. RIGHTS & DUTIES OF MEMBERS: All and every member of the "VSHFA"

- a) Administer the oath of the office and loyalties to the "VSHFA" and/or its constitution.
- b) Shall be entitled to participate in the meetings called/ arranged by the "VSHFA"
- c) has one vote at every meeting:
- d) Elect the Governing Council of the "VSHFA". (Subject to the provisions in clause 5(i).
- e) Attend the General Body meetings.
- f) Give the necessary information to the "VSHFA" pertaining to any matter which is necessary to be known by the "VSHFA."
- g) Not indulge in activities which are prejudicial to the interest of the Rules & Regulations of the "VSHFA".
