4. Dr. Gurmukh Jagwani ji has informed about the sad demise of Shri Sai Darshan at Lucknow. A two-minute silence was observed, and a condolence letter is to be sent to Lucknow.
5. The minutes of the previous meeting, passed unanimously.
6. The Advisory Team, comprising Shri Rajaram Bhagwani ji, Shri Manohar Mamtani ji, and Dr. Ravi Prakash Tekchandani ji, deliberated on the matter in consultation with Advocate Sachet Makhija. It was suggested that the association may be converted into a Section 8 Company; however, such conversion can be undertaken only after carrying out the necessary amendments.

It was further noted that the 30-day period will conclude on 12th May 2026. Thereafter, a meeting may be convened, and the proposal can be placed before the General Body for approval to convert the association from the Society Act to a Section 8 Company. So, the new committee will decide on the conversion from the Society Act to a company.
